

REVISED GUIDELINES FOR THE CONTRIBUTORS

Aitihya - The Heritage is a Bi-annual, Peer Reviewed (refereed), Multi-lingual Research Journal on Indology in English, Bengali, and Assamese within the discipline of Arts and Humanities and Social Sciences related to India. The core area of this journal rests on Indology which is a combination of the study of language, culture, history, political, legal, economic, environmental, etc. of Indian sub-continent and related issues.

PAPER SUBMISSION GUIDELINES

TITLE PAGE

The title of the paper, name (s), professional/academic affiliation(s) and full postal address (es), including email, phone numbers of the author(s) should appear on a separate title page, as manuscript will be submitted for anonymous reviews. Note one of the authors as the corresponding author.

BLINDED MANUSCRIPT

Do not include any personal information as the file will be used for blind review

Title of the paper gets repeated here exactly as it appears on the title page

Abstract : This page should contain an abstract not exceeding 250 words followed by five keywords in alphabetical order in a separate line.

The manuscripts should adhere to the prescribed format as applicable :

1. *Introduction / Background of the Study*
2. *Statement of the Problem*
3. *Literature Review and Research Gap*
4. *Research Queries (if any)*
5. *Objectives of the Study*
6. *Hypothesis (optional)*
7. *Methodology of the Study*
8. *Critical Analysis / Discussion / Results and Findings*
9. *Conclusion (include the future scope of research in the area)*
10. *Citations and References*

Typescripts : Typescripts should be double-spaced with normal margins on all sides with 12-point Times New Roman font (Times_Norman for diacritical marks). In case of Assamese & Bengali manuscripts, Ramdhenu Software with Geetanjali Font may be used. A hard copy of the research paper must also be sent to the editor. However, the abstract for all the manuscripts in any language must be written in English only.

Length of the Manuscripts : All manuscripts must be composed in MS Word. Length of the research paper must be approximately 3,500 - 5,000 words including notes and references.



Also, a typical research manuscript should not exceed five figures and five tables containing caption and source. Manuscript should be 'spell-checked' and 'grammar-checked'.

References : The main text shall be marked with Arabic number in a serial order as superscript wherever there arises any case of reference. References should be cited at the end of the text in the following style:

[Books] ⇒ Author's name : *Title of the Book*, Vol., Edition, Name of the Publisher, Year, Page No.

[Edited books] ⇒ Author's name : Title of the article, published in
[Editor(s) name] (Ed.) : *Books title*, Edition, Name of the Publisher, Year, Page No.

[Journal(s)] ⇒ Author's Name : Title of the paper, *Journals name*, Vol., Issue, Year, Page No.

[Other sources] ⇒ As usual.

Academic Ethics : Aitihya-The Heritage expects all submitting authors must adhere to academic ethics. The article submitted to the journal must be original. The authors must note that the article submitted to the Journal for consideration for publication must not be submitted to any other journal concurrently or till the outcome of the submission is communicated. Entries must also be accompanied by a plagiarism check document. Authors will be liable for any violation of the norms of copyright. Entries must be accompanied by a declaration from all the contributors of the paper that the entry is not barred by the terms of 'Research Misconduct'.

I/We hereby confirm that the paper entitled, submitted to the editor of "Aitihya-The Heritage" is an unpublished research work and has not been submitted to anywhere else for publication.

General Guidelines : Authors should follow the rules stated here for submission of the manuscripts. Primarily the submitted articles are considered by the editors for the confirmation of the standard and the scope of the journal. If any submitted article fails to fulfill primary standard, the same will be rejected which will be informed only on enquiry after a waiting period of at least three months. If the editors are satisfied, the article entries would go through the process of blind peer review. The rule also applies to the members of the Editorial board. It is imperative to note that the editor will subject every entry through a rigorous pre-review. The authors should take care to ensure that the content in the manuscript does not offend/hurt the sentiment of any community and does not use any defamatory or derogatory language. Paper may be sent at any time of the year. Editorial Board is not liable to give any explanation for rejection of any paper.
